

Incorrect.

Direct variation: As one quantity rises, so does the other at a constant rate. This can be represented by:  $y = kx$

Inverse variation: As one quantity increases, the other quantity decreases. This can be represented by:  $y = \frac{k}{x}$

Joint variation: More than two quantities are needed. This can be represented by:  $y = kxz$
